Singapore, **28 October 2009** – SGX Mainboard-listed MTQ Corporation Limited ("MTQ" or "Group") is pleased to announce today that its Australian subsidiary, MTQ Engine Systems (Aust) Pty Ltd ("MTQES") has entered into a strategic partnership with Robert Bosch Australia ("Bosch") to expand its current product offering to include a full range of Bosch automotive products targeted at the automotive aftermarket in Australia.

According to a recent paper issued by the Australian Automotive Aftermarket Association in August 2009, the automotive aftermarket sector contributes over \$8 billion annually in economic activity and employs 300,000 people in vehicle maintenance and repair, the manufacture and supply of aftermarket equipment and vehicle recycling.

Under this collaboration, known as "Bosch Superstore", MTQES is awarded distribution rights to all of the Bosch product range in the Automotive Aftermarket segment. This makes MTQES the first in Australia to be able to offer a comprehensive one-stop solution for customers looking for Bosch products. To be located within MTQES' outlets, Bosch Superstore will carry

a wide range of Bosch's key products such as spark plugs, wipers, filters, brakes, starter motors, alternators and more.

MTQES has a wide network in 9 branches across Australia. In partnering Bosch, MTQES will leverage on such competitive edge to attract greater pool of new and existing trade customers, in particular the aftermarket repair demands for petrol powered vehicles, one market to which MTQES so far has little exposure.

To add icing to the cake, Bosch Superstore will also carry PBR, one of Australia's leading suppliers of brake system technology. The PBR brake range has recently been coupled with the Bosch brake range to establish the most comprehensive range of brake products available from a single entity.

Commencing from 1 November 2009, Bosch Superstore will be launched at major MTQES locations in Australia. As MTQES already has the established network of branches linked by a common advanced ERP platform, incremental costs such as personnel and warehousing expenses are estimated to be minimal.

For the six months ended 30 September 2009, MTQES contributes about 49% of total revenue at Group level. With the development of this initiative, the Group expects the turnover of the Australian business to increase substantially in the near future.
